Adoption: **Local Law No. One, 1971, District Attorney Petty Cash Fund**

RESOLUTION FINALLY ADOPTING LOCAL LAW NO. ONE OF THE COUNTY OF STEUBEN FOR THE YEAR 1971 IN REGARD TO THE CREATION OF A PETTY CASH FUND FOR THE STEUBEN COUNTY DISTRICT ATTORNEY'S OFFICE IN FURTHERANCE OF HIS LAW-

FUL DUTIES, in pursuance of the Municipal Home Rule Law of the State of New York and the provisions of Section 376 of the County Law, duly adopted by the Board of Supervisors, Steuben County, New York on the 16th day of August, 1971, a quorum of said Board being present and 28 supervisors voting in favor thereof and no supervisors voting against the same.

WHEREAS, on the 19th day of July, 1971, a local law as hereinafter set forth was adopted subject to a Public Hearing and in accordance with said resolution and notice this Board of Supervisors did conduct a Public Hearing thereon as stated in the Notice of Public Hearing on the 16th day of August, 1971 at 10:30 A.M., and all persons appearing were given the opportunity to be heard concerning the local law, and the Clerk of the Board having filed in her office proof of the publication of such notice of the public hearing in the Corning Leader of Corning, New York and the Evening Tribune of Hornell, New York, and also having filed in her office proof of the posting of the notice of the public hearing on the bulletin boards at the respective County Court Houses in the Village of Bath, City of Hornell and City of Corning, now therefore, be it hereby

RESOLVED, that Local Law No. One of the year 1971 of the County of Steuben, New York, is finally adopted, to wit:

**COUNTY OF STEUBEN
LOCAL LAW NO. ONE OF THE YEAR 1971**

A LOCAL LAW CREATING A PETTY CASH FUND IN THE AMOUNT OF ONE THOUSAND (\$1,000.00) DOLLARS IN THE STEUBEN COUNTY DISTRICT ATTORNEY'S OFFICE.

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF STEUBEN AS FOLLOWS:

Section 1. There is hereby created a revolving petty cash fund in the amount of One Thousand (\$1,000.00) Dollars in the Steuben County District Attorney's Department pursuant to the provisions of Section 376 of the County Law of the State of New York and as spelled out in Section 371 of the same law, for use by the District Attorney in furtherance of his lawful duties.

Section 2. Moneys from said fund may be paid in advance for lawfully obtaining information and evidence required by the District Attorney and the District Attorney is required to make a full accounting for such sums withdrawn from the petty cash fund and there shall be a subsequent audit and approval of all claims by the Judges and District Attorney's Committee of the County Board of Supervisors and by the Steuben County Board of Supervisors.

Section 3. The Steuben County Treasurer is authorized and directed to do on her part all things necessary to establish said petty cash fund and make the necessary transfer of moneys to the fund for the purpose herein set forth.

Section 4. This local law shall take effect after a public hearing on the same, final adoption by the Steuben County Board of Supervisors and approval of the Chairman of the Board of Supervisors.
