RESOLUTION FINALLY ADOPTING COUNTY OF STEUBEN LOCAL LAW NO. THREE OF THE YEAR 1974 AUTHORIZING CONVEYANCE BY THE COUNTY OF STEUBEN TO THE STATE OF NEW YORK DEPARTMENT OF ENVIRONMENTAL CONSERVATION OF APPROXIMATELY 16.98 ACRES OF THE COUNTY SOCIAL SERVICES FARM REAL PROPERTY IN THE TOWN OF BATH, NEW YORK,

Pursuant to Sections 214 and 215 of the County Law and Sections 10, 20 and 27 of the Municipal Home Rule Law of the State of New York.

WHEREAS, the County of Steuben Local Law No. Three of the Year 1974 was duly presented and adopted by this Board on the 19th day of August, 1974, subject to the holding of a Public Hearing on September 16, 1974, and

WHEREAS, in accordance with the said resolution and notice of Public Hearing, this Board did conduct a Public Hearing on the 16th day of September, 1974 at 10:30 A.M. in the Supervisors' Chambers in the Village of Bath, New York, on the matter of the adoption of County of Steuben Local Law No. Three of the Year 1974, and

16.98 acres of Social Services Farm real property to the New York State Department of Environmental Conservation for the consideration of One (\$1.00) Dollar, payment to be waived, for the purpose that said property shall be used by the State of New York as a headquarters for the Environmental Conservation Department and other similar uses including a wildlife refuge. Said property is located in the Town of Bath, Steuben County, New York and is more particularly described in a survey and map to be made a part of said deed and as filed with the Steuben County Board of Supervisors on August 19, 1974.

SECTION 2. The conveyance of said real property is deemed to be in the public interest, however, such conveyance shall provide that should the real property cease to be used by the State of New York for the above mentioned purposes, that title to the same shall revert to the County of Steuben, together with all improvements placed thereon and being a part of said real property.

SECTION 3. This local law shall take effect immediately upon its filing with the Secretary of State of the State of New York and upon its publication in accordance with Section 214 of the County Law of the State of New York.

BE IT FURTHER RESOLVED, that within five (5) days after the final adoption of said Local Law, the Clerk of this Board shall cause to be filed one certified copy in the office of the New York State Comptroller, four certified copies in the office of the Secretary of State of the State of New York and one certified copy in the office of the Steuben County Clerk, and the Secretary of State is requested to publish the Local Law in the supplement to the Session Laws and the Steuben County Clerk is to be requested to file the Local Law in a separate book kept by him for such records, and be it further

RESOLVED, that the Clerk of the Board shall cause a true copy of said Local Law to be published in the county official newspapers at least once a week for two successive weeks, the first publication of which shall be had within ten (10) days after such Local Law has become effective, and be it further

RESOLVED, that the Clerk of this Board shall forward certified copies of this resolution to Mr. Arthur Flick of the New York State Environmental Conservation Department at Bath, New York, to the County Commissioner of Social Services, to Attorney Robert H. Cole, Counsel to the County Social Services Department, and to the County Attorney.
