SECTION 1: LEGISLATIVE INTENT

It is the intent of the within Local Law to amend Local Law No. Five for the Year 1990, Resolution No. 200-90, "Relative To The Steuben County Ethics And Disclosure Law In Compliance With Article 18 Of The General Municipal Law", so as to include requests for public inspection of financial disclosure statements as records for public inspection pursuant to the Public Officers Law Article Six.

SECTION 2: AMENDING LOCAL LAW NO. FIVE FOR THE YEAR 1990.

Local Law No. Five for the Year 1990 be, and the same hereby is, amended to read as follows:

Relative to the Steuben County Ethics and Disclosure Law in compliance with Article 18 of the General Municipal Law.

SECTION VI; Subdivision 4 (i).

i) Notwithstanding the provisions of Article Six of the Public Officers Law, the only records of the Board of Ethics which shall be available for public inspection are:

- (2) financial disclosure statements filed pursuant to this Local Law and requests for public inspection of said statements;




