SECTION 1: LEGISLATIVE INTENT

It is the intent of the within Local Law to comply with Chapter 30, Laws of New York, 1996, providing the Retirement Incentive Program.

SECTION 2: ELECTION OF PROGRAM

The County of Steuben hereby elects to provide all its eligible employees with a retirement incentive program authorized by Chapter 30, Laws of 1996.

SECTION 3: COMMENCEMENT DATE

The commencement date of the retirement incentive program shall be July 1, 1996.

SECTION 4: OPEN PERIOD

The open period during which eligible employees may retire and receive the additional retirement benefit, shall be ninety (90) days in length.

SECTION 5: COUNTY ANNUAL PAYMENT

That the employer will fund the Retirement Incentive Program provided by Chapter 30, Laws of 1996, by paying to the New York State and Local Employees' Retirement System in five (5) annual payments, the amount of which shall be determined by the Retirement System Actuary, the first payment for which is due December 15, 1997.

SECTION 6: EFFECTIVE DATE

This Local Law shall take effect immediately upon passage.




