**SECTION 1.** The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One Dollar (\$1.00), and payment of advertising costs, to convey to Robert N. Austin Post 1279 the following tract of land:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Campbell, County of Steuben and State of New York and generally described in accordance with J. Patrick Moore sketch map as follows:

Commencing more or less at a certain Monument set opposite to County Route 333; thence generally westerly and parallel to said County Route 333 and 50± southerly of the centerline of said road a distance of 375± to a point opposite and approximately 25± easterly of the centerline of the Curtis Campbell Road; thence running generally southerly and parallel a distance of 25'± from the centerline of said Curtis Campbell Road a distance of 160'±; thence generally easterly a distance of 100'± along the old centerline of the road; thence at right angles a distance of 24.75' to a point; thence generally easterly along the old right of way of the road a distance of 290'± to the point or place of beginning.

**SECTION 2.** The within statute shall be construed as an offer to convey to, and option to purchase the subject premise, by Robert N. Austin Post 1279. Failure or refusal to furnish consideration on or before November 6, 1997 shall terminate the within offer.

**SECTION 3.** This local law shall become effective subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.


