SECTION 1. The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One Dollar (\$1.00), and payment of advertising costs, to convey to Vincent Mahany and Anne Hoy the following tract of land:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Hornellsville, County of Steuben, State of New York and being more particularly bounded and described as follows:

Beginning at a set 5/8" steel pin and cap in the northerly line of County Road No. 70A; said point being at Baseline Station J50+42.26, 48' left; thence through the lands of the County of Steuben

- 1) S52 30'25"W, 373.38' to a set 5/8" steel pin and cap; thence on a non-tangent curve to the right, having a
- 2) Delta = 62 57' 37"
Radius = 357.50'
Arc Length = 392.85' to the POINT AND PLACE OF BEGINNING

CONTAINING 0.305 acre of land.

Subject to all easements and rights-of-way on record.

SECTION 2. The within statute shall be construed as an offer to convey to, and option to purchase the subject premise, by Vincent Mahany and Anne Hoy. Failure or refusal to furnish consideration on or before February 4, 1999 shall terminate the within offer.




