A local law authorizing the sale of certain property owned by the County of Steuben to (Insert title) Steuben Contracting, Inc.

Be it enacted by the STEUBEN COUNTY LEGISLATURE of the (Name of Legislative Body)

SECTION 1. The Chairman of the Steuben County Legislature, be and the same hereby is authorized and directed for and in consideration of the sum of Thirty-Two Thousand Dollars (\$32,000.00) to convey to Steuben Contracting, Inc., the following tract of land:

Beginning at a point in the east boundary line of the premises of the party of the first part 200 feet north of the north line of the macadam highway, which extends from Elmira, N.Y. to Corning, N.Y.; thence westerly and parallel with said north line of said highway 297 feet more or less to the east line of a lane which extends into and upon the premises of the party of the first part, northerly from said highway; thence northerly along the east line of said lane 740 feet; thence easterly and parallel with said north line of said highway 442 feet more or less to the east boundary line of the premises of the party of the first part; thence southerly along said east boundary line 528 feet more or less to the division line between the premises of the party of the first part and lands of Amanulet Rhinehart; thence westerly along said division line 148 feet more or less to the east line of the premises of the party of the first part; thence southerly along said east line 212 feet more or less to the place of beginning.

SECTION 2. The within statute shall be construed as an offer to convey to, and an option to purchase the subject premises by Steuben Contracting, Inc. Failure or refusal to furnish the consideration on or before June 30, 1986, shall terminate the within offer.

This local law shall become effective, subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.
