SECTION 1. LEGISLATIVE INTENT. It is the intent of this Local Law to amend Section 3 of Local Law No. Five for the year 1984 to require payment in full of the current town and county tax bill where a delinquent taxpayer seeks to repurchase his property.

SECTION 2. AMENDMENT OF SECTION 3 OF LOCAL LAW NO. FIVE FOR THE YEAR YEAR 1984 - Section 3 of Local Law No. Five for the Year 1984 be and the same hereby is, amended to read as follows:

Provided the latest current year's town and county tax bill in its entirety, including penalties and interest, is paid, the treasurer shall allow delinquent taxpayers to redeem individual annual certificates issued against their property. The oldest certificate issued shall be redeemed first.

SECTION 3. EFFECTIVE DATE - The within Local Law shall be effective October 1, 1991.


