A local law Authorizing the Sale of Certain Property Owned by the County of  
(Insert Title) Steuben to the Town of Rathbone

Be it enacted by the LEGISLATURE of the

SECTION 1. The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One Dollar (\$1.00), and payment of advertising costs, to convey to the Town of Rathbone the following tract of land:

ALL THAT PIECE OR PARCEL OF PROPERTY situated in the Town of Rathbone, County of Steuben, State of New York, described as follows:

Beginning at the point of intersection of the property line, between the Town of Rathbone on the southeast and Harold Widger on the northwest, reputed owners, and the center line of the existing County Road No. 21; thence north 34 deg. 20' west 130 more or less feet along the aforesaid center line to a corner point; thence south 56 deg. 20' west 58 more or less feet to a corner point; thence south 11 deg. 30' east 135.5 more or less feet to a point on the aforesaid property line; thence north 58 deg. 37' east 110.0 more or less feet along the aforesaid property line to the point of beginning and containing 0.19 acres of land, more or less.

SUBJECT to all easements and rights of way of record.

SECTION 2. The within statute shall be construed as an offer to convey to, and an option to purchase the subject premise, by the Town of Rathbone. Failure or refusal to furnish consideration on or before February 28, 1994 shall terminate the within offer.

SECTION 3. This local law shall become effective subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.




