SECTION 1. The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed to convey to the Steuben County Industrial Development Agency the following tract of land:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Bath, County of Steuben and State of New York and being further bounded and described as follows:

BEGINNING AT a set 5/8" steel pin and cap in the southerly bounds of N.Y.S. Route 54 said point being 720.2' westerly of the intersection of said bounds and the centerline of County Road No. 113. thence along said bounds

- 1.) S63 35'59"W, 35.06' to a point; thence
- 2.) S57 22'11"W, 135.00' to a concrete monument; thence
- 3.) S53 56'10"W, 30.19' to a concrete monument; thence along the lands of the V.F.W.
- 4.) S33 10'20"E, 200.00' to a set 5/8" steel pin and cap; thence through the lands reputedly of the County of Steuben
- 5.) N56 49'40"E, 200.00' to a set 5/8" steel pin and cap; thence
- 6.) N33 10'20"W, 194.56' to the POINT AND PLACE OF BEGINNING

CONTAINING 0.913 ACRE OF LAND.

SECTION 2. As and for consideration for the conveyance of property described in Section 1., the Steuben County Industrial Development Agency shall convey the following tract of land:

All that tract or parcel located in the Town of Bath and commencing at a point at the intersection of the easterly line of the right-of-way of The Bath And Hammondsport Railroad Company and the southerly line of the right-of-way of County Route #113, thence generally in an easterly direction along the right-of-way of County Route #113, 100 feet to a point; thence 400 feet on a line parallel to the aforementioned The Bath And Hammondsport Railroad Company right-of-way to a point, thence 100 feet perpendicular to a point on the easterly line of The Bath And Hammondsport Railroad Company right-of-way, thence northerly along The Bath And Hammondsport Railroad Company right-of-way 400 feet to the point and place of beginning, said parcel of property consisting of a portion of that property commonly kown and designated as the Steuben County Farm.

SECTION 3. The conveyance of the aforementioned property to the Steuben County Industrial Development Agency shall provide that should the real property cease to be used by the Industrial Development Agency that title to same shall revert to the County of Steuben.

SECTION 4. This local law shall become effective, subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.


