SECTION 1: LEGISLATIVE INTENT

It is the legislative intent of the within Local Law to repeal Local Law No. 8 for the Year 1984. Local Law No. 8 for the Year 1984 provided that alternative veterans exemptions authorized by Real Property Tax Law Section 458-a would not be allowed. By repealing Local Law No. 8 for the Year 1984, alternative veterans exemptions would now be allowed. It is the further legislative intent of the within Local Law to exercise the option relative to limitations of the exemption of taxation as provided in Real Property Tax Law Section 458-a(2)(d)(ii) so as to permit the maximum exemption allowable in Real Property Tax Law Section 458-a(2), Paragraphs "a", "b", and "c" to be limited to \$6,000, \$4,000 and \$20,000, respectively.

SECTION 2: REPEAL OF LOCAL LAW NO. 8 OF THE YEAR 1984

Local Law No. 8 for the Year 1984 be, and the same hereby is, repealed.

SECTION 3: ELECTION OF LIMITATIONS REDUCING THE MAXIMUM EXEMPTION

The maximum exemption allowable in Paragraphs "a", "b", and "c" of subdivision 2 of the Real Property Tax Law Section 458-a be, and the same hereby are, established at \$6,000, \$4,000 and \$20,000, respectively.

SECTION 4: EFFECTIVE DATE

The within Local Law shall be effective immediately upon passage subject to Real Property Tax Law Section 458-a(4).




