SECTION 1: LEGISLATIVE INTENT - It is the intent of this local law to exercise local home rule authority and to continue the designation of The Leader of Corning, New York and The Evening Tribune of Hornell, New York as the two official County newspapers until such time as is superseded by subsequent resolution of the Steuben County Legislature.

SECTION 2: DESIGNATION OF NEWSPAPERS - The Leader of Corning, New York and The Evening Tribune of Hornell, New York be, and the same hereby are, designated as the official newspapers of the County of Steuben for purposes of complying with County Law Section 214(2) until such time as is superseded by subsequent adoption of a resolution of the Steuben County Legislature.

SECTION 3: EFFECTIVE DATE - This local law shall be effective immediately upon adoption.


