SECTION 1:

The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One (\$1.00) Dollar, and payment of advertising costs, to convey to the Steuben County Industrial Development Agency the following tract of land:

THAT PARCEL OF PROPERTY commonly known and designated as the old County Farm, located in the Town of Bath, the western portion thereof, lying west of the Bath-Hammondsport Railroad right-of-way, and east of County Route 54, located to the north and south of County Route 113.

SECTION 2:

The County Administrator is authorized and directed to execute any and all necessary documentation to facilitate the within conveyance including but not limited to compliance with all rules, regulations, laws and ordinances of the State of New York.

SECTION 3:

This Local Law shall become effective subject to a permissive referendum, forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.




