**SECTION 1.** The Chairman of the Steuben County Legislature be, and the same hereby is, authorized and directed for and in consideration of the sum of One Dollar (\$1.00) to convey to Floyd Loper, Jr. the following tract of land:

ALL THAT TRACT OR PARCEL OF LAND, being a portion of Great Lot 21 in Township 4 of the sixth Range of Townships, situated in the Town of Fremont, County of Steuben, State of New York bounded and described as follows:

Commencing at a point in the center of County Route 70-A at a distance of 351.8 ± feet measured westerly along the center of County Route 70-A from its intersection with the center of County Route 57;

Thence S20°19'58"W along the division line between the properties of the Loper, (L.923, Pg. 28) and Poklinowski (L.1299, Pg. 73) in part, and Loper, (L.923, Pg. 28) and Olin (L.1137, Pg. 12) in part, a distance of 298.77 feet to an iron pin set at the point of beginning of the parcel to be conveyed;

Thence S20° 19'58"W a distance of 85.82 feet to an existing concrete right of way marker;

Thence N68°37'05"W a distance of 241.02 feet to an iron pin;  
Thence N81°50'12"W a distance of 265.82 feet to an iron pin;  
Thence N79°27'08"W a distance of 1107.08 feet to an iron pin;  
Thence N05°39'36"W a distance of 70.83 feet to an iron pin;  
Thence S79°49'03"E a distance of 1118.76 feet to an iron pin;  
Thence S86°14'41"E a distance of 190.69 feet to an iron pin;  
Thence S71°25'07"E a distance of 339.00 feet to the point of beginning.

The above described parcel contains 121,774 square feet or 2.796 acres more or less.

Intending to convey by this description the lands acquired by the County of Steuben by the following:

[A] Acquisition Map #6.03 acquired from Floyd Loper and Eleanor Loper by deed dated May 20, 1930 and recorded in Steuben County Clerk's Office in Liber 415 of deeds at Page 358.

[B] Acquisition Map #6.05 acquired from Floyd Loper and Eleanor Loper by an assumed unrecorded deed. (No record of deed found in Steuben County Clerk's Office.)

**SECTION 2.** The within statute shall be construed as an offer to convey to, and option to purchase the subject premise, by Floyd Loper, Jr.. Failure or refusal to furnish consideration on or before August 24, 1998 shall terminate the within offer.

**SECTION 3.** This local law shall become effective subject to a permissive referendum forty-five (45) days after the date of its final adoption and on the date it is duly filed in the Office of the Secretary of State of New York and in accordance with the provisions of the Municipal Home Rule Law of the State of New York.




