**SECTION 1: LEGISLATIVE INTENT**

The purpose of this Local Law is to amend Local Law No. Four for the Year 2000, to provide an increase in the income of qualified persons from \$18,500.00 per annum to \$19,500.00 per annum, relative to persons with disabilities.

**SECTION 2: AMENDMENT OF LOCAL LAW NO. FOUR FOR THE YEAR 2000 – SECTION 4.D.1**

Local Law No. Four for the Year 2000, Section 4.D.1, be and the same hereby is, amended to read as follows:

“If the income of the owner or the combined income of the owners of the property for the income tax year immediately preceding the date of making application for exemption exceeds the sum of Nineteen Thousand Five Hundred (\$19,500.00) Dollars.”

**SECTION 3. EFFECTIVE DATE**

The within Local Law shall be effective immediately upon passage and applicable the next tax year following.




